REQUIRED DOCUMENTATION

Please forward the following information along with your registration. If you do not yet have all documentation, please forward what is currently available.

- Copy of the recorded conservation easement.** This means a copy which has the recording information stamped on each individual page. If you have not yet received such a copy, you may contact the title company that closed the transaction, your attorney (if applicable) or the land trust holding the easement for assistance in obtaining such a copy.

- Full copy of the qualified appraisal (and any related updates) for the donated conservation easement.** A black and white copy is sufficient. Photos and maps need not be in color.

- Copy of form 8283** demonstrating the value of the donation. **Please be sure to include the required attached statement (new as of 2006) as set forth in the IRS instructions for Form 8283.** Please be sure that the form has been signed by the donee and appraiser of the conservation easement.

- Copy of a *current* Title Commitment (without exception documents) OR *current* Title Insurance Policy.** The Title Commitment or Title Insurance Policy must be effective within 60 days of the recordation date of the easement.

- Copy of “mineral remoteness” letter.** This is required *only* if the the donor does not own the mineral rights to the property.

- Copy of Subordination Agreement(s).** This is required only if the property is subject to a mortgage, deed of trust or similar lien.

- Copy of the signature pages(s) of the baseline report.** Please be sure the document has been signed by the donor and the donee organization.

- Copy of the donee acknowledgement letter.** This letter will have been provided to the donor by the donee organization evidencing the easement donation and stating whether or not any consideration was provided in exchange for the donation.

BY EXECUTING THIS REGISTRATION FORM I AGREE TO THE FOLLOWING:

1. I will make the above-described Tax Credit available for transfer through Conservation Resource Center's Tax Credit Exchange, in one or more transactions, subject to my approval, through April 15, 2008.
2. I will accept payment of 83% of the face value of a transferred Tax Credit. This price may be higher, depending on the Tax Credit Exchange's year-end survey of sale prices.
3. I acknowledge that I will be required to sign an agreement and other documents with the Buyer whereby I will guarantee that the Tax Credit is valid, and indemnify the Buyer if the Tax Credit is not valid. I recognize that the Tax Credit Exchange may choose to not match my credit with a Buyer because the Exchange believes, in its sole discretion, that the Conservation Easement donation may not qualify for tax credits.
4. I give permission to copy all of the documents supplied with this Registration, and to distribute them to any parties involved with this transaction. Additionally, I hereby give permission to the appraiser of the above referenced appraisal to supply the entire appraisal to any parties involved with this transaction, and I give permission to the recipient of the Conservation Easement to supply all background information related to the Conservation Easement to any parties involved with this transaction.
5. I acknowledge that the Tax Credit Exchange will attempt to match my Credits with a Buyer, and that the earliest participants in the Exchange will generally be given priority in matching. I further acknowledge, however, that the Exchange may match Buyers and Sellers based on other priorities, such as a match of the size of the Credits, or a match pre-identified by a Buyer or Seller when they came to the Exchange. Finally, I acknowledge that it may not be possible to match my Credits with a Buyer this year, in which case I will simply retain the un-transferred Credits.
6. I acknowledge that the Conservation Resource Center, and its officers, agents and representatives, are operating the Tax Credit Exchange solely to further the Center's own nonprofit goals, and are not acting as my agent or representative. I further acknowledge that I have been advised to seek my own tax, legal and other professional advice for matters related to this transaction, and that I am not relying on any representations or statements by the Conservation Resource Center or its representatives, except as may be made in writing.
